

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.SavvyRenity.com and Douglas Dynasty, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Douglas Dynasty, LLC include www.SavvyRenity.com, SavvyRenity, Douglas Dynasty and www.SavvyDiaries.com. The SavvyRenity website is a Religious, Blog, Information site. By using the SavvyRenity website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered on our Site, SavvyRenity may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase SavvyRenity's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

SavvyRenity may also collect anonymous demographic information, which is not unique to you, such as your:

Use of your Personal Information

Sharing Information with Third Parties

SavvyRenity may sell, rent, or lease customer information to third parties for the following reasons:

Marketing

SavvyRenity may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is transferred to the third party.

Tracking User Behavior

SavvyRenity may keep track of the websites and pages our users visit within SavvyRenity, in order to determine what SavvyRenity services are the most popular. This data is used to deliver customized content and advertising within SavvyRenity to customers whose behavior indicates that they are interested in a particular subject area.

Automatically Collected Information

Information about your computer hardware and software may be automatically collected by SavvyRenity. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the SavvyRenity website.

Use of Cookies

The SavvyRenity website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server.
